

# Nxt Gen Futsal League

## Terms and Conditions

### 1. Introduction

These Terms and Conditions ("Terms") govern your participation in Nxt Gen Futsal League competitions, events, and services. By registering a team or participating in any capacity, you agree to be bound by these Terms.

### 3. Registration and Participation

#### 3.1 Team Registration

- Teams must register by the specified deadline (August 16th, 2025 for Autumn 2025 League)
- Registration requires completion of all required forms and payment of applicable fees
- Maximum squad size: 12 players per team
- Minimum age requirements must be met for respective age categories (U10, U12, U14, U16)

#### 3.2 Player Eligibility

- All players must meet age criteria for their respective categories
- Valid player registration and insurance documentation required
- Players may only represent one team per competition
- Birth certificates or equivalent age verification may be requested

### 3.3 Team Requirements

- Teams must provide home and away kit in contrasting colors
- Goalkeepers must wear distinguishing colors
- Indoor footwear with non-marking soles mandatory
- Teams must have designated team manager/contact person

## 4. Competition Format and Rules

### 4.1 League Structure

- Autumn 2025 League: 10-week competition starting September 13th, 2025
- Alternating weekend format with guaranteed fixtures
- Each team plays minimum 10 games across the season
- Maximum 6 teams per age group

### 4.2 Match Rules

- Matches governed by official FA Futsal Rules
- Game duration: 25 minutes with 5-minute breaks between matches
- Unlimited rolling substitutions permitted
- Professional referees provided for all matches

### 4.3 Scheduling

- No matches during school half-term (October 25th & November 1st)

- Match times: Early session (1pm-4pm), Late session (4pm-7pm)
- Fixture lists distributed by August 25th, 2025

## 5. Fees and Payment

### 5.1 Registration Fees

- Autumn 2025 League: £35 per team per fixture (£350 total season)
- Payment options: Full season payment, split payments, or per-fixture
- Multi-team discounts available: 2 teams (5% discount), 3+ teams (10% discount)

### 5.2 Payment Terms

- Registration deposit: £100 per team upon registration
- Full payment due before first match or as per selected payment plan
- Late payment may result in fixture suspension
- All fees are non-refundable except as outlined in our Refund Policy

### 5.3 Additional Costs

- No additional costs for referees, venue hire, or basic equipment
- Trophies and medals included in registration fee
- Optional services (photography, additional coaching) charged separately

## 6. Conduct and Discipline

### 6.1 Code of Conduct

- All participants must adhere to principles of fair play and respect
- Abusive language, unsportsmanlike behavior, or violence strictly prohibited
- Respect for officials, opponents, and spectators required at all times

- Zero tolerance policy for discrimination or harassment

## 6.2 Disciplinary Procedures

- Disciplinary action may include warnings, suspensions, or disqualification
- Serious misconduct may result in immediate removal from competition
- Appeals process available for disciplinary decisions
- Final decisions rest with league management

## 6.3 Team Responsibilities

- Teams responsible for conduct of all players, coaches, and supporters
- Team managers must ensure compliance with all league rules
- Damage to venue or equipment may result in additional charges

## 7. Health and Safety

### 7.1 Insurance and Liability

- All participants must have appropriate insurance coverage
- Nxt Gen Futsal League maintains public liability insurance
- Participants engage at their own risk
- Medical emergencies handled according to venue procedures

### 7.2 Safeguarding

- Comprehensive Safeguarding Policy in place
- All coaches and volunteers subject to appropriate checks
- Safeguarding concerns reported immediately to designated officer
- Child protection procedures strictly followed

### 7.3 Medical Requirements

- Teams must provide emergency contact information
- Medical conditions must be disclosed on registration
- First aid facilities available at all venues
- Players with injuries must have medical clearance to participate

## 8. Intellectual Property and Media

### 8.1 Photography and Video

- Nxt Gen Futsal League reserves right to photograph/video events
- Images may be used for promotional purposes
- Participants consent to use of likeness in marketing materials
- Opt-out available upon written request

### 8.2 Social Media

- Participants encouraged to promote league positively on social media
- Inappropriate social media content may result in disciplinary action
- Official league social media accounts: @nxtgenfutsalleague

## 9. Data Protection and Privacy

### 9.1 Data Collection

- Personal data collected for registration and competition administration
- Data processed in accordance with GDPR and UK data protection laws
- Information shared only with relevant parties (venues, referees, FA)

### 9.2 Data Security

- Appropriate security measures in place to protect personal data
- Data retention periods in line with legal requirements
- Participants have right to access, correct, or delete personal data

## 10. Cancellation and Force Majeure

### 10.1 League Cancellation

- Nxt Gen Futsal League reserves right to cancel competitions if necessary
- Cancellation due to insufficient registrations, venue unavailability, or force majeure
- Refunds processed according to Refund Policy

### 10.2 Force Majeure

- Events beyond reasonable control (pandemic, government restrictions, natural disasters)
- League may be postponed, modified, or cancelled due to force majeure
- Alternative arrangements made where possible

## 11. Complaints and Disputes

### 11.1 Complaints Procedure

- Formal complaints must be submitted in writing within 7 days of incident
- Complaints reviewed by league management committee
- Response provided within 14 working days

### 11.2 Dispute Resolution

- Disputes resolved through internal procedures first
- Mediation services available for unresolved disputes

- UK consumer protection rights apply

## 12. Website and Technology

### 12.1 Website Use

- Website provided for information and registration purposes
- Users responsible for ensuring information accuracy
- Website terms of use apply to all interactions

### 12.2 Communication

- Primary communication via email and website updates
- Teams responsible for monitoring communications
- Important updates sent to registered team contacts

## 13. Sponsorship and Commercial Activities

### 13.1 League Sponsorship

- Nxt Gen Futsal League may enter into sponsorship agreements
- Sponsor recognition included in league materials and events
- Teams may not conflict with official league sponsors without permission

### 13.2 Team Sponsorship

- Teams may secure individual sponsorship subject to approval
- Sponsor logos on kit permitted within reasonable limits
- Inappropriate sponsorship may be rejected

## 14. Amendments and Updates

## 14.1 Terms Changes

- Terms may be updated to reflect legal requirements or operational changes
- 30 days notice provided for material changes
- Continued participation constitutes acceptance of updated terms

## 14.2 Rule Changes

- Competition rules may be modified for safety or fairness
- Changes communicated to all registered teams
- Mid-season changes only for essential reasons

## 15. Governing Law

### 15.1 Jurisdiction

- These Terms governed by English and Welsh law
- Disputes subject to jurisdiction of English and Welsh courts
- FA rules and regulations take precedence for football-related matters

## 16. Limitation of Liability

### 16.1 Liability Limits

- Nxt Gen Futsal League liability limited to registration fees paid
- No liability for indirect, consequential, or special damages
- Participants assume risk of injury or property damage

### 16.2 Indemnification

- Participants indemnify league against claims arising from their participation



- Teams responsible for actions of players, coaches, and supporters

## 17. Severability

If any provision of these Terms is found invalid or unenforceable, remaining provisions continue in full force and effect.

## 18. Entire Agreement

These Terms, together with the Refund Policy and Safeguarding Policy, constitute the entire agreement between parties.
